SELECTION PROCEDURE:

The selection will be made through a personal interview on merit basis. Candidates who are called for interview will not be paid any TA & DA.

PROCEDURE TO APPLY:

Only candidates possessing MD (in Ayurveda) qualification in the specialty mentioned above need to apply. Application form is separately appended to this notification. Every candidate should submit the application only in the prescribed format. Application not in the prescribed format will summarily be rejected.
