Mandatory criteria:

Age:

Should not have completed 45 years as on 01.07.2011.

Experience:

for the post of Professor: Total teaching experience of **ten years** in the concerned subject is necessary out of which there should be **five** years teaching experience as Reader / Associate Professor in the concerned subject or ten years teaching experience as a Lecturer in the concerned subject in an Ayurveda Medical College & Hospital in the recognized by the CCIM.

for the post of Reader: Total teaching experience of **five years** in the subject is necessary out of which there should be **three years** teaching experience as Lecturer in the subject concerned in an Ayurveda Medical College & Hospital in the recognized by the CCIM.
