2) The Assistant Surgeons in Tamil Nadu Medical Service for considering selection to the post of Health Officer in Tamil Nadu Public Health Service in **the Pay Band of Rs.15600-39100 plus Rs.5700 Grade pay** should furnish an undertaking to the effect that they are willing to be permanently absorbed as Health Officer in Tamil Nadu Public Health Service and will not request this department for reversion as Assistant Surgeon in Tamil Nadu Medical Service. The Assistant Surgeons in TNMS on selection as Health Officer in Tamil Nadu Public Health Service have to acquire public health qualification within four years from their date of joining duty as Health Officer in Tamil Nadu Public Health Service for becoming full member of the service. They shall be deputed to undergo Medical Council of India recognized courses as service candidate.
