Resident Medical Officer – counselling to be conducted on

It is proposed to conduct counselling to fill up the vacant posts of  
Resident Medical Officer under the control of this Directorate on **08.3.2012.Fore  
Noon at 9.00 a.m.**

The terms and conditions for taking up the Resident Medical Officer posts  
are as follows:

1. Any Medical Officer with or without Post Graduate Degree Qualification / Diploma are eligible to attend the counselling
2. Preference will be given to the Medical Officer who has administrative experience like Assistant Resident Medical Officer / Deputy Warden / Administrative Officer in-charge / Junior Administrative Officer in-charge in the Medical College / Hospital.
3. Medical Officers who have been promoted as Associate Professor are not eligible. However, if he/ she prefers, they should give a declaration that they will not come back to Teaching Side for a minimum period of 3 years.
- (a) The Medical Officers those who have already completed 15/20 years of regular services and redesignated / refitted as Civil Surgeon in the Pay Band –III and Chief Civil Surgeon in the Pay Band –IV will be considered for the post of Resident Medical Officer .
4. Those who have been posted as Resident Medical Officer should continue as Resident Medical Officer till their superannuation or till they opt for transfer to other Directorates.
5. They should give an undertaking that they will stay in the Quarters allotted for Resident Medical Officer .
6. They shall not do private practice and if any violation in this regard is noticed, action will be taken as per Government Service Rules against the individual concerned.

7. It is transferable post, if necessary within the institutions under the control of Director of Medical Education as Resident Medical Officer
8. It is a Non-Teaching post and hence the period of service as Resident Medical Officer will not be taken into account for calculation of Teaching Experience.

**The willing Medical Officers working under the control of this Directorate alone are eligible to attend the counselling.**

The Annexed Proforma and the Service particulars as per the (Service Register) has to be filled up and 2 copies have to be sent by the Head of the Institutions on or before the cut off date **29.2.2012 at 5.00 pm** to this Directorate will only be considered for counselling.
